# Leaving a Beloved Home, Creating a Legacy

Doris passed away in 2020 and left her entire estate to People Who Care. We are so grateful for her generosity. Doris has, indeed, created a lasting legacy that will help sustain People Who Care and support the independence of others as they age in place.

## How to Become a Legacy Donor

There are many ways to become a legacy donor, including:

### **Bequests**

Make a gift from your will or trust. This can include gifts of property, such as stock or real estate.

### **Retirement Accounts**

Name "People Who Care" as the beneficiary and enjoy tax benefits.

### **Life Insurance and Annuities**

Name "People Who Care" as the beneficiary. A charitable gift annuity pays you income for life with the remaining value going to People Who Care.

### **Charitable Trusts**

Choose from a variety of strategies available for legacy planning.

### **Qualified Charitable Distributions (QCDs)**

In addition to these legacy strategies, there is a lifetime strategy available to people over the age of 70 1/2. You can request a direct donation (QCD) from your IRA to People Who Care, and that amount is not included in your reportable income. Additionally, if you are over 73 1/2 and need to take required minimum distributions (RMDs), you can direct part of your RMD to be directly sent to PWC, and that QCD is also not included in your income. There are several tax rules for this strategy, so please consult your adviser.

To learn more about legacy giving – including the many tax advantages – consult your attorney, financial advisor, or tax accountant. They can offer guidance on which giving options are best for you.
